| SUBJECT: | Mobile Outreach Response Engagement Stabilization (MORES) and Mobile Response Stabilization Services (MRSS) Update |

This Joint Communication Bulletin clarifies that Mobile Outreach Response Engagement Stabilization (MORES) and Mobile Response Stabilization Services (MRSS) are State-funded pilots and not NC Medicaid State Plan services. These services are being offered by Local Management Entities/Managed Care Organizations (LME/MCOs) and are funded by the Division of Mental Health/Developmental Disabilities/Substance Abuse Services.

- These services **should not** be billed to Medicaid using the Mobile Crisis Management codes (H2011, H2011HT, H2011GT, or H2011KX).
- For children and adolescents under age 21, MORES and MRSS may be requested under the <u>Early and</u> <u>Periodic Screening, Diagnostic and Treatment (EPSDT) benefit</u> if all EPSDT criteria are met.

The MORES State-funded pilot service is available to eligible individuals, regardless of payer source.
