Timeline

May 2, 2023
Executive Order signed declaring NC age-friendly state and formalizing MPA initiative.

June 5, 2023
Hosted All Ages, All Stages kickoff meeting.

August 2023
Finalized steering committee.

September 7, 2023
Convened stakeholder workgroup meeting.

September 2023 to February 2024
Stakeholder workgroups meet to develop objectives and recommendations.

September to November 2023
Conduct focus groups.

January-February 2024
Begin work on public information campaign

March 2024
Steering committee receive workgroup objectives and recommendations

March 4, 2024
Reconvene stakeholder workgroups. Begin soliciting public input.

March 2024
Share objectives and recommendations with cabinet representatives. Begin drafting report. Incorporate input and feedback as needed.

April 2024
Refine report draft and share with stakeholders for additional input. Launch public awareness campaign.

April to May 2024
Establish 2-year outcome metrics and finalize data dashboard.
