#### Introduction

North Carolina General Statute 120-208.4.(b) requires the Department of Health and Human Services (DHHS) to submit an annual report on the use of lapsed salary funds by each Division within the Department. For each Division, the report shall include the following information about the preceding State fiscal year:

- (1) The total amount of lapsed salary funds.
- (2) The number of full-time equivalent positions comprising the lapsed salary funds.
- (3) The Fund Code for each full-time equivalent position included in the number reported pursuant to subdivision (2) of this section.
- (4) The purposes for which the Department expended lapsed salary funds.

Lapsed salary is the dollar amount not expended for salary and associated benefits (social security, retirement, longevity, and medical insurance contributions) during the period in which a position is vacant within the course of the fiscal year because of the employee's separation, reassignment, leave or unpaid leave of absence. Lapsed salary can only be used for one-time, non-recurring expenditures. These funds may not be used to establish new permanent positions or to raise the salary of existing employees.

The majority of DHHS employees are in the Department's 14 state operated healthcare facilities. These facilities provide direct medical care 24 hours per day, 7 days per week. These medical, clinical and highly skilled positions are necessary for these facilities to provide required patient care and also represent the hardest positions to fill and retain.

In state fiscal year 2023-2024, DHHS generated \$321.9M in lapsed salary; of this amount, \$234.9M was repurposed for under-budgeted line items. Of the \$234.9M that was repurposed, \$90.7M was from state appropriations and \$144.2M was from Departmental receipts. Not surprising based on the number of employees and challenges with recruitment and retention of staff, approximately 79% of the lapsed salary that was generated and repurposed was used within the budget code for the Division of State Operated Healthcare Facilities (DSOHF) and the Division of Mental Health Developmental Disabilities and Substance Abuse Services (DMHDDSAS). As delineated below, lapsed salary funds are primarily being used to cover other personnel- related costs that may have been under budgeted or, when positions take longer to be filled, that make it possible for the work of the agency to still be completed.

#### **Summary of Primary Usage:**

- Cost related to overtime pay, holiday pay and shift premium differential pay for DHHS permanent staff
- Workman's compensation costs
- Costs to cover temporary services for critical positions during the period that they are vacant (recruitment and hiring period)
- Legal and administrative costs in support of DHHS programs and operations

• Mitigate chronic budgetary shortfalls within the Department

This report covers State Fiscal Year (SFY) 2023-2024, the period July 1, 2023 through June 30, 2024. The report is organized into three sections:
