Vecinos, Inc. Opens Community Hub in Franklin

"Vecinos, a non-profit free clinic and rural health center dedicated to serving uninsured and underinsured residents, has opened a new permanent location in Franklin.

The new Macon County community health hub will serve residents of Cherokee, Clay, Graham, Jackson, and Swain counties in Western North Carolina.

Marianne Martinez, CEO of Vecinos, said the new facility has been four years in the making.

"This space is more than just a building," Martinez said. "It's a promise. A promise that no one's income, no one's background, no one's health insurance status should

The 16,000-square-feet facility will offer primary care, dental and behavioral health services. It will also house Pisgah Legal, Centro Communitario of Macon County, WNC Alliance, and Mountain Projects to provide legal service, tax preparation services, health insurance enrollment assistance and more."

#### Community Care Clinic of Franklin Opens New Location from Macon Sense

"Community Care Clinic of Franklin recently moved to a new location at 121 Riverview Street in Franklin. Since 2010, the clinic has provided free primary, preventive, and acute healthcare to the low-income, uninsured residents of Macon and surrounding counties. The new location provides space to expand services and better attend to needs of patients. Added at the new location is a behavioral health program, which is available both inperson and through telehealth. Clinic hours have expanded as well to five daytime clinics and two evening clinics each week, allowing staff to see more patients and offer limited walk-in availability. In addition to continuing no-cost care for eligible patients, Community Care Clinic will begin accepting N.C Medicaid and Healthy Blue plans due to the shortage of Medicaid providers in the area."

classes with support from funded health coaches, provide stress management sessions led by a certified Zen instructor, secured two AEDs and provided training on AED use and hands-only CPR. They have also worked on community Integration by developing strong partnerships with local officials (mayor, town council) and by laying the foundation for sustainability beyond current funding.

#### Moore Free and Charitable Clinic – Implementing an Integrated Care Model

The Moore Free and Charitable Clinic, located in Moore County, has implemented a true integrated healthcare model focusing on whole-person care.

Key Services they offer include

- Physical therapy, full dental services (including on site dental implants), and podiatry.
- Extensive behavioral health support.
- Staff include patient navigator and referral coordinator to streamline access.
- Vision and Impact:

This integration project aims for cost savings, improved patient satisfaction, and reduced care fragmentation. They have also ensured sustainability of this strategy via sponsorships, private donors, and ORH funding.

### Office of Rural Health Telehealth Infrastructure Grant Program

The Office of Rural Health will accept applications for Wave 4 of the Telehealth Infrastructure Grant (official date to be announced). This grant provides funding to rural healthcare providers for start-up equipment and related items for telehealth with priority given to independent primary care practices and independent OB-GYN practices that will enhance healthcare access, quality, and outcomes. This includes deploying telehealth technology, developing secure data management systems, and creating comprehensive training initiatives for practice staff and/or patients. This effort will allow patients being served in a primary care or OB-GYN setting to access non-hospital-based telehealth services.

All rural North Carolina-based **primary care** practices, including independent primary care practices and independent OB-GYN practices, are eligible to apply. Applicants must:

- Be located within the state of North Carolina
- Demonstrate the ability to maintain patient safety, ensure patient privacy and continuity of care
- Provide evidence that they have a quantifiable and qualifiable record of healthcare provisioning relative to grantee requirements as detailed in Session Law, SECTION 9B.7A.(a)
- Demonstrate the capacity and capability to implement telehealth infrastructure projects, including technology deployment, system integration, and workforce and patient training.

Projects submitted under this RFA must:

- Provide evidence the service is an equitable healthcare delivery model, including anticipated outcomes related to impact on health care delivery and/or social determinants of health in the primary care and OB-GYN community.
- Indicate which populations are the intended audience (historically underserved, marginalized, or adversely affected groups,

PART 1 - About 1 in 10 Americans has diabetes, with 90-95% of those having Type 2 Diabetes. (CDC) The majority of these people receive health care in the primary care setting (Pilla et. al). Physiologically, diabetes affects multiple organ systems, as well as the emotional well-being of the affected person. Medicine regimens can be complex, especially for an older person with other chronic conditions. To enable the practice staff to support the person with Type 2 Diabetes, this course uses case studies of familiar patients seen in primary care. Practical office-based clinical assessment and patient education concepts are presented. Basic pharmacology of diabetes drugs, laboratory tests used to assess and monitor the disease and common physical exam findings are covered. Register online at

PART 2 - Managing diabetes requires much more than taking medicines and visiting the primary care provider's office--lifestyle changes at the heart of a person's very self are needed. People with diabetes are 2-3 times more likely to have depression than those without diabetes (CDC). Typically considered a lifelong chronic condition, Type 2 diabetes requires the affected person to incorporate it into their self-image and work every day on difficult behavior changes. Mood disturbances may also be the result of physiologic changes caused by the illness, or from medication side effects. Building on the foundation of Part 1 of this series, this module focuses on the impact a diagnosis of Type 2 Diabetes can have on the mental health of patients they see in primary care. ### Collaborative Care Management Capacity Building Fund

Starting April 1, 2025, applications opened for Phase 1 and Phase 2 Practices. The NC General Assembly has earmarked \$5 million for capacity building for Medicaid-enrolled primary care practices across the state to adopt Collaborative Care Management (CoCM). The NCDHHS Division of Mental Health, Developmental Disabilities, and Substance Use Services (DMHDDSUS) is contracting with CCNC to manage the program in partnership with NC AHEC"s Practice Support coaching. CoCM is an evidencebased behavioral health integration model designed to support primary care clinicians in assessing and treating patients with mild to moderate behavioral health conditions. An evidence-based model shown to be more effective than usual care, CoCM improves patient outcomes, increases satisfaction for both patients and

### NC Medicaid Provider Enrollment NCDHHS-DHB Credentialing Committee Initiative Stakeholder Engagement Session #3

Please join NC AHEC and the North Carolina Department of Health and Human Services (NCDHHS), Division of Health Benefits (DHB), for the third stakeholder teleconference on June 25 from 2-3 p.m. to continue the discussion of a new initiative led in tandem with General Dynamics Information Technology (GDIT). This initiative will establish a Credentialing

providers, and reduces healthcare costs and the stigma related to mental health and substance use disorders.

The capacity building fund has a maximum award of \$50,000 per practice. A primary care practice entity applying on behalf of multiple primary care practice sites may receive a maximum of three awards per entity. Each clinic site may be eligible to receive awards of \$50,000 to begin a CoCM model in-house. Additionally, \$30,000 is available for practices to expand an existing in-house CoCM Model, and \$20,000 is available to practice sites meeting Phase 1 eligibility, but planning to outsource staffing to a third-party, turn-key company.

They support callers by helping them to navigate the behavioral health systems, and providing follow up until the individual is connected to sufficient support. #### **Community Crisis Centers**

Community crisis centers are safe places where you can get help without going to the emergency room. They offer immediate help with mental health needs and treatment for alcohol or drugs. Most are open 24 hours a day, 7 days a week. You don't need an appointment. Crisis centers take Medicaid but you don't need insurance to get care at one.
