Program Name: Child Care Resource and Referral Services Program

Purpose of the RFA: The purpose of this Request for Application is to provide technical assistance to early care and education programs according to NC's technical assistance framework: North Carolina's Professional Development Framework for Continuous Quality Improvement and develop a professional development learning community (PLC) to increase the management skills for current and aspiring child care directors and serve as a resource hub for families receiving child care.

Description: The North Carolina Child Care Resource and Referral (CCR&R) Core Services Program is designed to ensure that 1) families have access to the information needed to become informed consumers of early care and education programs; 2) early educators have access to professional development and consultation services to help them improve their instructional practices and overall operations; and 3) families have access to enroll their children in high quality child care and early education programs.

Funding Availability: This RFA will be for a 3-year funding cycle with an optional 2-year renewal term. Up to **four (4) awards of up to \$2,000,000 per year** will be made under this RFA to provide services in each of the regions of North Carolina as outlined in the chart below. Eligibility for renewals is contingent upon contract compliance, project performance, and availability of funding. The initial contract period will be July 1, 2026 – June 30, 2029.

DCDEE will determine the actual funding amount based on the proposed execution of the project and the utilization of funds as outlined in the successful applicant's proposal, pending funding availability
