Detailed Plan for Reorganizing the Division of Child and Family Well-Being Programs Session Law 2022-74, Section 9B.1.(a)

Reporting Requirement

North Carolina Session Law 2022-74, Section 9B.1.(a) directs the North Carolina Department of Health and Human Services (DHHS) to submit a detailed plan and timeline for transferring certain child and family well-being programs and services to a new division.

Session Law 2022-74, Section 9B.1.(a)

By October 1, 2022, the Department of Health and Human Services (Department) shall submit a detailed plan and timeline to the Joint Legislative Oversight Committee on Health and Human Services and the Fiscal Research Division on its proposal to transfer certain child and family well-being programs and services to a new division within the Department. At a minimum, the plan shall include the following:

- (1) The mission and purpose of the proposed new division.
- (2) A list of the specific programs and services to be transferred to the new division.
- (3) A detailed proposed budget for the new division, including:
 - a. The specific budget codes and fund codes that would be impacted by the creation of the new division and the transfer of certain child and family well-being programs and services into the new division.
 - b. Identification of any positions that would be transferred to the new division.
 - c. An estimate and explanation of any realignment or reapportionment of State funds or federal block grant funds that would be necessary to implement the proposed reorganization. If any fund codes are being split, the estimated dollar amount that will be allocated to each division.
- (4) Anticipated impact on local governments and key service providers.
- (5) Identification of the specific functions, powers, duties, and obligations that would need to be transferred to the new division in order to implement this proposed reorganization.
- (6) Any legislative changes that would be necessary to implement this proposed reorganization.
- (7) Any other information the Department deems relevant to implementing this proposed reorganization.

Executive Summary

Introduction

In January 2022, North Carolina Department of Health and Human Services (DHHS) established the Division of Child and Family Well-Being (DCFW), following requirements as outlined in North Carolina General Statute §143B-10(b). DCFW brings together staff and programs serving the behavioral health, physical health, and social needs of children and families. Under DCFW, programs and staff that previously operated under three separate Divisions with broad missions are unified under one Division dedicated to the well-being of children and families.

Mission & Purpose

DCFW was established to position DHHS to care for the whole child by breaking down siloes. DCFW's purpose is to improve child and family well-being to support DHHS's mission to ensure that all children are healthy and thrive in safe, stable, and nurturing families, schools, and communities. DCFW works to integrate behavioral health, physical health, and social programs to provide coordinated and streamlined whole-person care. DCFW was established based on many internal and external partner and legislative meetings and conversations held over the past several years that highlighted the growing needs of children, youth and families combined with increasing recognition that the most effective strategies to meet these needs require a coordinated, cross-sector approach.

Programs & Services

DCFW brings together complementary health and human service programs that serve children, youth, and their families. The new DCFW brings together programs and staff that were operating across department divisions, Division of Public Health (DPH), Division of Social Services (DSS), and Division of Mental Health, Developmental Disabilities, and Substance Abuse Services (DMHDDSAS), referred throughout this report as "originating divisions," to support children, youth, and their families' physical, behavioral, and social needs under one unifying Division. Focusing on these areas allows DCFW to dedicate its services to whole person care.

These programs include:

- Nutrition programs for children, families, and seniors Special Supplemental Nutrition Program for Women, Infants, and Children (WIC), the Child and Adult Care Food Program (CACFP), and the Food and Nutrition Services Program (FNS);
- Health-related programs and services for children and youth, such as school health promotion, home visiting services, supports for children and youth with special health care needs, genetics and newborn screening programs;
- School and community behavioral health services for children and youth, including
 coordination with schools to provide behavioral health training and supports to school
 personnel and programs that increase access to behavioral health services and supports in
 the community;
- Early Intervention/North Carolina Infant-Toddler Program, which provides supports and services to children ages zero to three with developmental delays or established conditions.

Positive Impacts & Early Wins

Increasing coordination enhances North Carolina's ability to meet and grow to respond to children and families' escalating and immediate needs in the aftermath of the COVID-19 pandemic. DCFW has brought new behavioral health supports in schools, in coordination with COVID-19 testing programs for schools, an example of streamlining how schools partner with DHHS to support student's behavioral and physical health. DCFW also prioritizes meeting the nutritional needs of infants and toddlers in the infant formula shortage and beyond, through our nationally recognized formula shortage response and efforts that have linked data across child-serving programs to boost nutrition and nutrition education for families.

Budget

DCFW's budget includes revenues, expenditures, and positions moved in alignment with the programs and services reorganized into the DCFW. From all sources, the budget totals \$570.3M, with \$514.9M from federal and other receipts, and \$55.4M in net state appropriations. The full-time equivalent (FTE) position count is 868.725. DCFW's budget was established in a budget neutral fashion.

Section (3) of this report provides a detailed budget for DCFW, and the specific budget codes, fund codes and positions impacted by creating DCFW as well as an explanation of realigned state and federal block grant funds and an estimated of fund codes split in the realignment.

Business Continuity for Service Providers

DCFW partners with local health departments (LHDs), local departments of social service (DSS) agencies, Local Management Entities/Managed Care Organizations (LME/MCOs), and non-governmental organizations to effectively administer programs (outlined in Tables I, II, III, and IV of this report) and deliver services to North Carolina children, families, and communities. DCFW ensures business continuity and stability for existing service delivery agreements and underlying service delivery systems by frequently communicating updates to partners, including contact information changes and administrative changes to contracts.

Functions, Powers, Duties, and Obligations

Pursuant to North Carolina General Statute §143B-10(b), DCFW was established in January 2022 to maximize services and outcomes for children and families. As required by the same statute, DHHS reported the reorganization to the General Assembly on February 18, 2022.

Legislative Changes

Certain programs administered by DHHS require statutory changes to reflect the alignment of child and family programs under DCFW. The specific statutory citations are outlined in this report.

Introduction

DHHS and its stakeholders have long identified the need from stronger cross-program coordination to better meet the needs of children and families and increase program effectiveness. The COVID-19 pandemic created greater urgency to increase coordination and effectiveness as children and families across the nation struggled with the physical and behavioral health and economic implications exacerbated by the pandemic. North Carolina was no exception. By the end of 2020, over 17% of children in North Carolina experienced food insecurity, representing the first increase in food insecurity rates since 2011¹. During the pandemic, the rate of children in North Carolina discharged from an emergency department with a behavioral health condition had increased by as much as 70%. As COVID-19's impacts became more apparent, the North Carolina Department of Health and Human Services (DHHSDHHS, Department) recognized the urgency of taking bold action to better meet the needs of North Carolina's children and families.

The Division of Child and Family Well-Being (DCFW) builds on the strength of individual programs and staff that previously operated under three distinct divisions (Division of Public Health (DPH), Division of Mental Health, Developmental Disabilities, Substance Abuse Services (DMHDDSAS), and Division of Social Services (DSS),, referred to throughout the report as "originating divisions," by uniting them under one division focused entirely on child and family wellbeing.

Programs

The programs moved under DCFW include (see Programs and Services Section for more detailed program list):

 Nutrition programs for children, families, and seniors – Special Supplemental Nutrition Program for Women, Infants, and Children (WIC), the Child and Adult Care Food Program (CACFP), and the Food and Nutrition Services Program (FNS);



- Health-related programs and services for children and youth that enable health in their schools and communities, such as school health promotion, home visiting services, supports for children and youth with special health care needs, genetics and newborn screening programs;
- School and community behavioral health services for children and youth, including coordination with schools using frameworks like System of Care, which supports the coordination of resources for children and families across multiple child service agencies; and
- Early Intervention/North Carolina Infant-Toddler Program, which provides supports and services to children ages zero to three with developmental delays or established conditions.

Planning and Launch Processes

DHHS created DCFW using an extensive planning process to prepare for the DCFW's creation from inception to operation. This process began in December 2020. Key process steps are presented in *Figure I. 2021-2022 DCFW Transition Timeline* and are described in more detail below.

Figure I. 2020-2022 DCFW Transition Timeline



(1) Mission & Purpose

On January 20, 2022, DHHS established DCFW to help the Department prioritize and reach the DHHS 2021-2023 Strategic Plan Goal 5: Improve Child and Family Well-Being.

As reflected in DCFW's February 18, 2022, reorganization report to the General Assembly, located in Attachment A, DCFW's purpose is to improve child and family well-being to support DHHS's mission to ensure that all children are healthy and thrive in safe, stable, and nurturing families, schools, and communities. DCFW is uniquely structured to care for the whole child by breaking down siloes. DCFW works to integrate behavioral health, physical health, and social programs to provide coordinated and streamlined whole-person care.

Increasing coordination enhances North Carolina's ability to meet and grow to respond to children and families' escalating needs in the aftermath of the COVID-19 pandemic. Specific examples include:

- Addressing children's growing behavioral health needs coming out of the pandemic: DCFW is bringing new behavioral health supports to schools, building upon deeper connections forged with schools during the pandemic. Most of the supports are funded and operated in coordination with the COVID testing program for schools, which is also operated out of DCFW. This coordination streamlines how schools partner with DHHS to support student's behavioral and physical health. In addition, DCFW played a leadership role in developing the Coordinated Action Plan focused on addressing the urgent crisis of the growing number of children with complex behavioral health needs who come into the care of child welfare services. A multi-sector Child Welfare and Family Well-being Transformation Team came together to collaborate on solutions. The Transformation Team includes leaders across DHHS Divisions (Medicaid, public health, behavioral health, social and economic services) and multiple external stakeholders (hospitals, private agencies, Local Management Entities, county DSS, practitioners, attorneys, and people with lived experience).
- Improving access to healthy foods and nutrition education and reducing food insecurity: An immediate priority for DCFW is addressing child hunger by helping eligible families access nutrition programs. DCFW's united structure brings together three major programs that address nutrition security: WIC, Child and Adult Care Food

Program (CACFP), and Food and Nutrition Services (FNS), formerly known as Food Stamps. DCFW has for the first-time linked data on families enrolled in WIC, FNS, and Medicaid to inform targeted outreach. Our initial focus will be on enrolling eligible FNS participants in the WIC program – which will boost nutrition and nutrition education for families with babies and toddlers. This work is in partnership with local health departments and local departments of social services. Thanks to increased cross-system coordination and the elevated leadership of DCFW, North Carolina WIC participation has increased by 21% since the onset of COVID-19, the greatest increase in the nation, according to a report by the Food Research & Action Center (FRAC). This increase reflects DHHS' ability to maximize federal programs to provide infants and toddlers with essential food and nutrition.

- Coordinating investments to improve child health and well-being: Funding to support child health and well-being is also often siloed across various federal, state and local sources. Maximizing the impact of investments for children's well-being requires coordination and prioritization. The unified DCFW leadership overseeing cross-sector programs facilitates better coordination for existing and new funding for child well-being programs. For example, multiple programs in DCFW intersect closely the NC Medicaid, which insures approximately half of the children in the state. DCFW coordinates closely with the Division of Health Benefits (DHB) to optimize coverage and supports for children and families during NC Medicaid Transformation, including operating the Care Management for At-Risk Children (CMARC) program; supporting the Prepaid Health Plans (PHPs) in outreach related to nutrition programs; and exploring coverage options that make it easier for children to access health supports in schools.
- Elevating child and family well-being services and needs for immediate action:

 During the national infant formula shortage, DCFW's structure and focus allowed DHHS to quickly mobilize to help babies and their families. Collaboration across programmatic areas focused on the comprehensive impact of the shortage encouraged pro-active, data-informed actions and outreach. The division could quickly evaluate federal opportunities to support North Carolinians, execute state-level flexibilities and leverage deep relationships with stakeholders. The strong coordination by DCFW resulted in North

Carolina being the first state to make broad-reaching flexibilities available to families participating in the Special Supplemental Nutrition Program for Women, Infants, and Children (WIC) and national recognition of our equitable and proactive response.

(2) Programs & Services

DCFW brings together complementary health and human service programs that primarily serve children, youth, and their families.

(3) Budget

DCFW's budget is comprised of revenues, expenditures, and positions moved in alignment with the programs and services reorganized into the DCFW. From all sources, the budget totals \$570.3M, with \$514.9M from federal and other receipts, and \$55.4M in net state appropriations. The full-time equivalent (FTE) position count is 868.725. As detailed below, DCFW was established in a budget neutral fashion.

The legislative report specified in Session Law 2022-74, Section 9B.1.(a) (3) requires "A detailed proposed budget for the new division, including:

(a) The specific budget codes and fund codes that would be impacted by the creation of the new division and the transfer of certain child and family well-being programs and services into the new division."

DHHS has standardized administrative service support definitions across all Divisions and Offices when possible to enable a uniform presentation of budget and expenditure data and information. The primary service support functions in each budget code include human resources, budget, purchasing and contract management, information technology, along with the management, policy development, and evaluation of services and activities necessary for the respective division to achieve its outcomes.

Regarding the specific budget codes and fund codes that are impacted by the creation of DCFW, *Table V. Funds Moving to DCFW* below identifies by division and fund code the requirements, receipts, and appropriations transferred to DCFW. *Table VI. The Budget Created for DCFW From the Funds in Table V* below presents the budget for DCFW created from funds transferred to DCFW.

Note, the following funds/services moved in their entirety:

- Division of Public Health (DPH) Fund 1272 Child and Adult Care Food Program
- Division of Public Health (DPH) Fund 13A2 Women, Infants and Children (WIC)
- Division of Public Health (DPH) Fund 1441 Early Intervention

Division of Social Services (DSS) Fund 1261 - Food and Nutrition Services - Nutrition
 Education

Several of the funds include multiple services; however, only some of the services are moving to DCFW. These will be further discussed in response to item 3(c).

Vacancies and associated state and federal funds to structure leadership positions and support administrative functions were realigned to DCFW from DMHDDSAS, the Division of Central Administration and Support, and the Division of Child Development and Early Education.

Federal Block Grant Funds:

Table IX. Realignment of Block Grants to Implement DCFW Reorganization captures the amount of federal block grant dollars that were being used to support service/program and positions activity within the originating divisions prior to transition to DCFW, as determined by division leadership. Of the 10 federal block grants administered by DHHS, two three are impacted by the establishment of DCFW.

The Child Care and Development Fund (CCDF) enables States to improve the availability, quality, and affordability of child care. Included in the current spending plan is an allocation for Child Care Health Consultant contracts, which will be transitioning to DCFW. Child Care Health Consultants (CCHCs) are health professionals who know about child health, child development, and health and safety in child care settings. CCHCs and the child care staff work together to promote healthy and safe environments for young children. CCHCs partner with child care providers to assess the health and safety needs and practices in child care facilities.

The Maternal and Child Health Block Grant enables States to maintain and strengthen their leadership in planning, promoting, coordinating, and evaluating health care for pregnant women, mothers, infants, and children and children with special health care needs in providing health services for mothers and children who do not have access to adequate health care. Women's Health Public Education, Maternal Health, Evidence-Based Programs in Counties with Highest Infant Mortality Rates, Perinatal Strategic Plan, Oral Health, State Center for Health Statistics, Teen Pregnancy Prevention Initiatives (TIPPI) Community Focus Infant Mortality and Health Promotion - Injury and Violence Prevention. Services in DCFW that are supported by this block grant include: Children's Preventative Health Services, Best Practices in Children's Health, Genetics and Newborn Screening, and School Health Services. Therefore, funds have been apportioned based on current budgeted amounts supporting the service/program areas that are moving to DCFW from DPH.

The Community Mental Health Services Block Grant (MHBG) supports states in carrying out plans for providing comprehensive community mental health services. The MHBG program targets adults with serious mental illnesses where their condition substantially interferes with, or limits, one or more major life activities, and children with serious emotional disturbances.

As previously referenced, there are several funds within the Department that contain more than one service. Therefore, a few notes regarding what these splits represent:

Division of Public Health (DPH) Services Remaining in the Division:

DPH Child and Adult Prevention (Fund 1271) – This fund contains five services, of which three moved. The services and respective funding remaining in DPH Fund 1271 are (1) Diabetes Awareness, Education & Health Care Delivery and (2) Tobacco Prevention and Control.

Therefore, the services moving to DCFW are: (1) Child Preventative Health Services, (2) Child Maltreatment Prevention and (3) Best Practices in Children's Health.

DPH Children Health Services (Fund 1332) – This fund contains four services, of which three moved. The service and respective funding remaining in DPH Fund 1332 is Teen Pregnancy Prevention Initiatives (TPPI).

Therefore, the services moving to DCFW are: (1) Child and Family Support Team, (2) Genetics and Newborn Screening and (3) School Health Services,

Division of Social Services (DSS) Activities Remaining in the Division:

Food and Nutrition Services were provided in DSS in three distinct services Food and Nutrition Services, Food and Nutrition Employment and Training, and Food and Nutrition Education.

Only funding and all activities for one of these services (Food and Nutrition Education) is moving in its entirety. DCFW is administering the key function of Food and Nutrition Services as well as Employment and Training.

Because some of the functions of these services encompass a broader array of economic support services, NC DSS will retain administration of those aspects. NC DSS maintains the relationship with the 100 county Departments of Social Services and serves as the county liaison and provides continuous quality improvement (CQI) measurement and support functions to the counties. As a result, DSS is implementing CQI using the same framework and tools across all programs, which includes the legislatively required Rylan's law performance MOU's.

DSS will also retain responsibility for the economic benefits call center, which supports multiple programs of which only part is moving to DCFW. The department does not have the capacity or resources to establish separate call centers for each economic benefit service.

Finally, the Equifax Work Number contract currently in the DSS budget will not transition to DCFW. This contract is used Department-wide to verify applicant employment history to determine eligibility status for multiple economic benefit programs.

Below is a summary of the functions/activities and associated funding remaining in DSS:

DSS Food and Nutrition Services (Fund 1372)

LIHEAP and Work First Help Desk EBT Call Center Food and Nutrition Services Monitoring Equifax Work Number Contract

Funding remaining in DSS for Services Moving to DCFW

DSS has the infrastructure for monitoring and reimbursing county expenditures. This is dependent upon a DSS/DHHS subsystem (County Admin System) that cannot process payments across Divisions due to limitations with the current subsystem. Therefore, the funding for FNS benefit payments will remain within the DSS budget until the current subsystem is replaced.

DSS Food and Nutrition Services (Fund 1372) (\$192M)

Food and Nutrition Services benefits processed through DSS/DHHS subsystem (County Admin System)

DSS Food and Nutrition Employment and Training (Fund 1482) (\$2.4M)

Food and Nutrition Employment and Training benefits processed through DSS/DHHS subsystem (County Admin System)

DMHDDSAS Services Remaining in the Division:

Child residential programs and services remain at DMHDDSAS. DMHDDSAS will continue to play a pivotal role in child behavioral health and coordinate with DCFW as residential services are an essential component of the service delivery system.

DCFW will support the overall behavioral health needs for children through evidence-based practices, capacity /workforce capacity building, system coordination, inclusion, and equity, as well as many other prevention and intervention programs to address children's behavioral, social, and health needs.

Service Support:

Regarding service support funding, as would be expected, all service support/administration funding was not reorganized from the originating divisions' Service Support (Fund 1110). Department leadership and others applied a process to determine the positions and funding needed to support DCFW at this time. As this is a new endeavor, this will have to be revisited once the DCFW has been operational for the current year.

(4) Impacts to Service Providers

DCFW partners with local health departments (LHDs), local departments of social services (DSS) agencies, Local Management Entities/Managed Care Organizations (LME/MCOs), and hundreds of non-governmental organizations to effectively administer programs (outlined earlier in Table III) and deliver services to North Carolina children, families, and communities. DCFW is maintaining business and program continuity by frequently communicating updates to partners, including contact information changes and administrative changes to contracts.

DCFW leverages existing structures and key partners to create efficiency. DCFW works through the NC Association of County Directors of Social Services (NCACDSS) and the NC Association of Local Health Directors (NCALHD) to efficiently engage with counties on, at least, a monthly basis. DCFW proactively provides policy, program, and operations updates, engages in discussion with counties regarding local needs and experience, and provides support, when needed. DCFW shared written communication and engaged in verbal discussion with counties about the transition to address any concerns, ensure business continuity at the local level, and provide efficiency solutions. An example of an efficiency solution is the three-way contract between DCFW, DPH, and LHDs that eliminated the need for an additional contract and the associated administrative burden.

DCFW's key transition goal is facilitating strategic coordination with contracted partners across funding streams and creating opportunities to maximize value and benefit to children and families. As an example, DCFW identified a provider agency contracting with three separate Divisions (DMHDDSAS, DPH, and Division of Health Benefits (DHB)) to provide similar child behavioral health services in different settings. DCFW coordinated with the Divisions and the provider to consolidate the contracts, now managed by DCFW. In the new contracts, DCFW modified the scope of work to reflect a collective and prioritized approach to behavioral health services, resulting in greater impact for children and families and increased efficiency for the provider.

(5) Functions, Powers, Duties, and Obligations

As established in the February 18, 2022, reorganization report to the General Assembly, child and family well-being is a key priority for DHHS coming out of the COVID-19 pandemic. Establishing DCFW reflects the Department's commitment to a vision that children are healthy and thriving in safe, stable, and nurturing families, schools, and communities. DCFW brings together physical, behavioral, and social programs, outlined in Tables I, II, III, and IV in this report, and staff serving children and families that previously operated in three separate divisions under one division. Reorganizing these programs under DCFW from DPH, DSS, and DMHDDSAS provides a laser-focus on children and families, removes structural silos, positions the administration of programs for children side-by-side, and facilitates greater program coordination, alignment, and efficiency. DCFW's goal is to prioritize the integration of behavioral health, physical health, and social programs to provide whole-person care in a coordinated and streamlined manner to meet children and families' escalating needs.

(6) Legislative Changes Necessary to Implement Reorganization

On February 18, 2022, the Department of Health and Human Services completed the requirement under North Carolina General Statute 143B-10(b) to report reorganization by department heads within 30 days after the reorganization by submitting the "Creation of the Division of Child and Family Well-Being" report to the Joint Legislative Committee on Government Operations Fiscal Research Division.

Certain programs administered by DHHS require statutory changes to reflect the alignment of child and family programs under DCFW; for example, adding DCFW to the Child Fatality Task Force and State Team in the Mental Health, Developmental Disabilities and Substance Abuse Act. Specific statutory citations amending the Elementary and Secondary Education statute, the Mental Health, Developmental Disabilities, and Substance Abuse Act of 1985, and the Executive Organization Act of 1973 are provided in italics below.

(7) Additional Information

The following provides relevant planning details of the multi-year DCFW transition process and highlights significant milestones.

Vision:

On April 15, 2021, Dr. Mandy Cohen, then DHHS Secretary, announced that DHHS would undergo a reorganization building on lessons learned in the Department's COVID-19 pandemic response. This reorganization focused on (1) Health Equity, (2) Whole Person Health, (3) Children and Families, (4) Preparedness, Response, and Recovery, and (5) Transparency and Accountability to better align the Department with DHHS's 2021-2023 Strategic Plan. DHHS' 2021-2023 Strategic Plan details seven goals and seven values and was created in the context of the COVID-19 pandemic³. The plan outlines objectives and strategies to be implemented throughout DHHS's work to provide essential services and improve the health, safety, and well-being of all North Carolinians.

The Secretary called for DHHS to create the new Division of Child and Family Well-Being to bring together behavioral health, health, and social programs from three Divisions, DPH, DMHDDSAS, and DSS, referred to as "originating Divisions" in this report, to provide a coordinated whole-person approach to care for children and families through integrated and enhanced services.

Launch Detail:

1. Conceptualization, December 2020 – April 2021

During the Conceptualization phase, the DHHS Secretary worked with the DHHS Deputy Secretaries to contemplate how the Department could recover stronger from COVID-19. COVID-19's disproportionate impact on children and families, from the disruption of routine childcare and schools to the loss of over 3,000 caregivers/parents to the virus, drove the need to take bold action to better meet their needs. The Secretary and Deputy Secretaries worked with originating Divisions' leadership to outline the contours of the Division focused on children and families, including which programs and services at DHHS intersect with the lives of children and

families from birth onwards. They also talked with key stakeholders, including members of General Assembly, about DCFW.

2. Program Alignment, May – November 2021:

During Program Alignment, executive leadership in the Office of the Secretary and across the originating divisions, as well as additional senior DHHS leaders worked collaboratively to (a) identify programs within their respective divisions that support the health and well-being of children and families and (b) determine which specific programs and staff should move to DCFW. To gather input and align with local partners, DHHS held multiple listening sessions with local health departments and local departments of social services about DCFW's vision and goals.

In October 2021, DHHS hired the inaugural DCFW Division Director to provide strategic and operational oversight and leadership for DCFW, including overseeing its budget, personnel, and program services.

3. Design and Transition Planning, November 2021 — January 2022:

In the Design and Transition Planning phase, executive leadership in the Office of the Secretary and cross-divisional leaders finalized the list of programs moving to DCFW and organized them into the following Sections:

- Community Nutrition Services Section (originating from DPH)
- Early Intervention Section (originating from DPH)
- Food and Nutrition Services Section (originating from DSS)
- Whole Child Health Section
 - Children and Youth (originating from DPH)
 - Whole Child Health Child Behavioral Health (originating from DMHDDSAS)

During this period, DCFW leadership met with legislators and local partners to discuss DCFW's benefit to children and families, DHHS partners, and the program leaders who worked with children and families.

Additionally, DCFW leadership established a Transition Leadership Team, comprised of transitioning program managers who understood the moving programs to drive understanding throughout the transition work. The Transition Leadership Team led DCFW Section Workgroups, one for each new section as well as separate Child and Youth and Child Behavioral Health workgroups for the Whole Child Health Section. Workgroups met weekly to collect, organize, and analyze key programmatic information related to human resources, regulatory considerations, budget and procurement/contracts, operations, internal and external communications, key performance measures, and technology infrastructure to create detailed transition plans.

4. DCFW Establishment: January 2022

In January 2022, DHHS Secretary Kody Kinsley established DCFW under the authority of Article III, Section 5(10) of the North Carolina Constitution and North Carolina Genera Statute §143B-10(b).

5. DCFW Phased Launch: February 1, 2022 – Present

DCFW transitioned its programs and services, followed by operational duties in three stages to maintain business continuity and ensure a smooth transition. The phased timeline approach (detailed in the bullets below) allowed DCFW leadership time to work collaboratively with originating division staff on program operations. In the first two phases, all transitioning programs moved into DCFW from their originating divisions (described in Programs and Services below).

- Phase I: Early Intervention and Community Nutrition Services Sections began their transition from DPH on *February 1, 2022*.
- Phase II: Whole Child Health Section programs began their transition from DPH and DMHDDSAS, and Food and Nutrition Services began their transition from DSS on March 1, 2022.
- Operational Phase: During an ongoing Operational Phase, DCFW Operational
 Transition Teams are developing a sustainable operational infrastructure for DCFW
 (described in Organizational Infrastructure below). These DCFW Operational Transition

Teams include DCFW leadership, staff from Office of the Secretary, and staff from these functional areas: budget, controller, Human Resources (HR), information technology (IT), legal, and facilities.

Transition Activities:

Programs and Services:

Beginning with Phase I in February 2022, DCFW assumed responsibilities for programs from their origination divisions through a warm handoff process where DCFW leaders assumed program supervision while continuing to coordinate with the originating division leadership to understand internal operations and external relations. This cross-divisional approach ensured smooth transitions and a pathway to maintain ongoing collaboration.

Furthermore, DCFW leadership developed an internal and external communications strategy to notify all staff and partners about the transition. Local and federal partners received formal notification that explained that their programs were moving to DCFW and linked to the DCFW public website. For internal stakeholders, DCFW hosted monthly Town Hall meetings for all transitioning and impacted staff to present regular updates and answer questions.

Organizational Infrastructure:

To focus on infrastructure transition activities, DCFW leadership formed the Operational Transition Teams. Leaders and subject matter experts from DHHS's Division of Budget and Analysis, Office of the Controller, Office of Procurement, Contracts, and Grants, Division of Human Resources, Division of Information Technology, Legal, Division of Property and Construction, DPH, DMHDDSAS, and DSS participated in these group. The Operational Transition Teams engaged with external state agencies as needed, such as the Office of State Budget and Management and the Office of State Controller, to plan and execute the budgetary, HR, regulatory, facilities, and IT frameworks to operationalize DCFW. Members of the Operational Transition Team started convening in August 2021 to work towards the following key transition milestones:

Budget and Procurement: Establishing the DCFW budget code in July 2022
 (complete). Transferring funding streams from originating divisions to DCFW (on

- schedule) and transitioning all contracts/addenda/allocations transitioned to DCFW (on schedule). See Budget Section of this report for changes in detail.
- Human Resources: Transferring employees moved from their originating divisions to DCFW in DHHS's Integrated HR-Payroll System (complete for 92% of DCFW staff).
- Regulatory: Identifying all statutes and rules that required modification (complete), with a plan to implement the changes during the 2023 legislative session. Statutes and rules that require modification are listed in the "Legislative Changes" section of this report.
- Physical Location: Working with the DHHS Division of Property and Construction and DPH to establish the DCFW Raleigh-based office at the Six Forks Campus alongside the DPH (complete). The decision to share a campus with DPH allowed the majority of DCFW staff, who transitioned from DPH, to remain in their physical offices.
 - Moving the Child Behavioral Health team's nine staff members from the Dix campus to the Six Forks Campus (complete).
 - Working with the NC DHHS Division of Property and Construction to identify space for the Food and Nutrition Services and DCFW Finance teams at the Six Forks Campus (in progress).
 - Maintaining staff who work across the state in Child Development Service
 Agencies (CDSAs) and operate the Early Intervention program at their
 services sites. These staff, who make up the majority of DCFW, do not require
 office space at the Six Forks Campus (complete).
- IT: Transferring IT subsystems that support payment to providers and vendors for various DCFW programs in three subsystem groups; the first two have been transferred (complete), with the final subsystem transfer is scheduled for 10/1/22 (on schedule).
 - Transferring IT access for all DCFW staff to ensure continued access to existing systems (in process).
 - Transferring documents and files from originating divisions to DCFW (in process).

Reporting Requirement

North Carolina General Statute 143B-10(b) requires the Department of Health and Human Services (DHHS) to report on Reorganization by Department Heads within 30 days after the reorganization.

§ 143B-10. Powers and duties of heads of principal departments.

(b) Reorganization by Department Heads. - With the approval of the Governor, each head of a principal State department may establish or abolish within his department any division. Each head of a principal State department may establish or abolish within his department any other administrative unit to achieve economy and efficiency and in accordance with sound administrative principles, practices, and procedures except as otherwise provided by law. When any such act of the head of the principal State department affects existing law the provisions of Article III, Sec. 5(10) of the Constitution of North Carolina shall be followed.

Each Department Head shall report all reorganizations under this subsection to the President of the Senate, the Speaker of the House of Representatives, the Chairmen of the Appropriations Committees in the Senate and the House of Representatives, and the Fiscal Research Division of the Legislative Services Office, within 30 days after the reorganization if the General Assembly is in session, otherwise to the Joint Legislative Committee on Governmental Operations and the Fiscal Research Division of the Legislative Services Office, within 30 days after the reorganization. The report shall include the rationale for the reorganization and any increased efficiency in operations expected from the reorganization.

Background

On January 20, 2022 the North Carolina Department of Health and Human Services (NCDHHS) established the Division of Child and Family Well-Being (DCFW). Child and family well-being is a key priority for NCDHHS coming out of the COVID-19 pandemic, and this reorganization reflects a commitment to the Department's vision that children are healthy and thriving in safe, stable, and nurturing families, schools, and communities. This reorganization to create a new Division within the Department brings together physical, behavioral, and social programs and staff serving children and families who currently operate in three separate Divisions under one Division. The reorganization of these programs under DCFW provides a laser-focus on children, removes structural silos, positions the administration of programs for children side-by-side, and facilitates greater program coordination, alignment, and efficiency.

Prior to this reorganization, these programs were embedded in Divisions with broader scopes than children. Planning sessions with senior leaders from the Division of Public Health (DPH), the Division of Mental Health, Developmental Disabilities, and Substance Abuse Services (DMHDDSAS), the Division of Social Services (DSS), local health departments, and local departments of social services informed alignment opportunities across units and programs that serve children, youth, and families. The goal of the Division is to prioritize the integration of behavioral health, physical health, social, and nutrition programs to provide whole-person care in a coordinated and streamlined manner to meet the escalating needs of children and families.

Introduction to the Division of Child and Family Well-Being

Programs

The programs moving under DCFW are primarily focused on improving the health and well-being outcomes of children and youth. These programs include:

- Nutrition programs for children, families, and seniors Special Supplemental Nutrition Program for Women, Infants, and Children (WIC), the Child and Adult Care Food Program (CACFP), and the Food and Nutrition Services/Supplemental Nutrition Assistance Program (FNS/SNAP);
- Health-related programs and services for children and youth that enable health in their schools and communities, such as school health promotion, home visiting services, supports for children and youth with special health care needs, genetics and newborn screening programs;
- School and community mental health services for children and youth, including coordination with schools and programs like System of Care that support the coordination of resources for children and families across multiple child service agencies; and
- Early Intervention/North Carolina Infant-Toddler Program, which provides supports and services to children zero to three with developmental delays or established conditions.

Rationale for the Reorganization

Children and families often bear the brunt of adversity. Investing in families and children's healthy development builds more resilient families, better educational outcomes and, in the long term, a stronger society. DCFW will work to ensure that North Carolina's children grow up safe, healthy, and thriving in nurturing and resilient families and communities. Bringing together these existing and complementary programs into a singular Division enables the Department to serve families and children efficiently and effectively and allows NCDHHS to support the health and well-being of more children by:

• Getting upstream of the behavioral health crisis. North Carolina, like the rest of the country, is facing a behavioral health crisis among children and youth. DCFW is part of NCDHHS's collective commitment to building innovative, coordinated and whole-person centered systems that recognize that physical, behavioral and social health are interdependent and that preventing the onset of health issues is the best way to support children thriving. DCFW will house preventive physical and behavioral health programs together – like nutrition programs, early intervention, home visiting programs – to keep more children on a healthy track. DCFW will work with teams across NCDHHS to build stronger, more comprehensive and coordinated community-based services so that more children can be cared for in their community, rather than in higher levels of care, such as in residential settings.

- Supporting student health in schools. NCDHHS forged deeper connections with schools
 during the pandemic. DCFW brings together most of the physical and behavioral health
 programs that support health in schools, which will make it easier for us to coordinate
 and prioritize our work. A strategic priority for DCFW is to increase access to mental
 health services for children and youth in schools, as well as other settings.
- *Making sure no child is hungry*. In establishing DCFW, NCDHHS brings together three major nutrition support and education programs for children and families: WIC, CACFP, and FNS/SNAP. A strategic priority for DCFW is to work with local health departments and local departments of social services to develop ways for families to more easily apply for programs like WIC and FNS/SNAP.
- Coordinating investments to improve child health and well-being. Maximizing the impact of funding for children's well-being requires prioritizing initiatives that work and making sure that families know about them and can access them. DCFW will be coordinating existing and new federal and state funding for child well-being related to the programs in the Division.
