SUN Bucks Basics

SUN Bucks, sometimes called Summer EBT, is a new federal program that helps families who qualify buy groceries during the summer using a debit-like EBT card.

To get SUN Bucks, the child must meet criteria set by the USDA. Some kids will automatically qualify, while others can apply. Children must individually qualify during the school year before the summer starts or they can apply over the summer.

Each student who qualifies will receive one payment of \$120 in benefits for the summer period.

Who Will Get SUN Bucks Benefits?

 FNS (food stamps) Work First (TANF, cash assistance) Medicaid with household income below 185% of the federal poverty level Foster care 	
All other Non-NSLP students are not eligible to apply for SUN Bucks.

When and Where will SUN Bucks Benefits be Issued?

Late June 2024 to September 2024: Summer 2024 benefits for qualifying students will be issued approximately every two weeks between <u>late</u> June 2024 and September 2024 as children are determined eligible.

- If the student has FNS benefits, SUN Bucks will be loaded to their existing account.
- If the student does not have FNS benefits, they will receive a SUN Bucks EBT card.

Activate a new card

To activate a card, the PIN activation code will be the birth date of one of the schoolaged children in the household. Families should try the birth date for each student in the household, starting with the youngest. Enter the birth date using two numbers for the month, two for the day, and four for the year. For example, if the birth date of the youngest school-aged child is Bucks is June 1, 2008, you would put in 06012008.
