Effective Dec. 1, 2021, The Department will implement the *Operational Guide for a Coordinated Response to a Sudden Closure of a Child Residential Care Facility*.

Any emergency closure of a residential care or treatment facility that results in the displacement of residents requires prompt, appropriate and well-coordinated actions. Response Teams are activated only in the event of an emergency facility closure, when a license revocation is in effect, or other sudden closure. The roles and responsibilities of each Response Team member is detailed in this guide.

DHHS is committed to assisting local management entities/managed care organizations, provider agencies and other local partners in anticipating and preparing for those situations.
